The Board has no reason to believe that the aforesaid matter has, or will have, any material adverse effect on the business and operations of the Group. Mr. Siu has confirmed with the Board that save as disclosed herein, there is no other matter that needs to be brought to the attention of the Company and its shareholders.

The Board will make further announcements as and when appropriate pursuant to the requirements under the GEM Listing Rules.
