DISCLOSEABLE TRANSACTION PROVISION OF FINANCIAL ASSISTANCE

On 22 August 2018, the Lender entered into the Loan Agreement with the Borrowers, pursuant to which the Lender agreed to grant a secured loan in amount of HK\$20,000,000 to the Borrowers.

As one of the relevant applicable percentage ratios set out in Rule 19.07 of the GEM Listing Rules with respect to the grant of the Loan Amount exceed 5% but not more than 25%, the provision of financial assistance constitutes a discloseable transaction of the Company under Chapter 19 of the GEM Listing Rules and is therefore subject to the notification and announcement requirements under the GEM Listing Rules.

LOAN AGREEMENT

Date : 22 August 2018

Lender : Yvonne Credit Service Company Limited, being an indirect wholly-owned subsidiary of the Company

Borrowers : Customer A and Customer B

Loan Amount : HK\$20,000,000

Loan Period : Fifteen days expiring on 6 September 2018 or such later date to be agreed between the Lender and the Borrowers

Repayment : Borrowers shall repay the principal amount with interest on 29 August 2018 and 6 September 2018 respectively

Interest : 40.8% per annum

Security : The property located in Hong Kong with a valuation of approximately HK\$40 million conducted by an independent property valuer on 30 July 2018.

The Loan Amount granted to the Borrowers was funded by internal resources of the Group.

The Lender and the Borrowers have not entered into any transactions within the past twelve months that need to be aggregated with the Loan Amount pursuant to Rule 19.22 of the GEM Listing Rules.

INFORMATION OF THE BORROWERS

Customer A is an individual. Customer B is a company incorporated in Hong Kong engaged in the business of properties investments. To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, the Borrowers are the Independent Third Party and not connected with the Group.

The Loan Amount is secured and carry an interest rate of 40.8% per annum which was determined with reference to the factors including, among others, (i) the usual practice of the trade comparing to the Group's other clients; and (ii) the rules under section 24 of the Money Lenders Ordinance.

REASONS FOR AND BENEFITS OF THE PROVISION OF FINANCIAL ASSISTANCE

The Group is principally engaged in money lending business, property investment, financial instruments, retail and wholesale business and quoted shares investment in Hong Kong. The Lender is an indirect wholly-owned subsidiary of the Company and a money lender licensed in Hong Kong under the provisions of the Money Lenders Ordinance. The terms of the Loan Agreement are negotiated on an arm's length basis between the Lender and the Borrowers. The Directors are of the view that entering into of the Loan Agreement is in the Group's ordinary and usual course of business; and on normal commercial terms within the meaning of the GEM Listing Rules. The Directors consider that the terms of the Loan Agreement are fair and reasonable and entering into the Loan Agreement is in the interests of the Company and the Shareholders as a whole.

As one of the relevant applicable percentage ratios set out in Rule 19.07 of the GEM Listing Rules with respect to the grant of the Loan Amount exceed 5% but not more than 25%, the provision of financial assistance constitutes a discloseable transaction of the Company under Chapter 19 of the GEM Listing Rules and is therefore subject to the notification and announcement requirements under the GEM Listing Rules.
